A. Discuss and Adopt Proposed 2023-24 Budget Resolution for General Fund, Community Schools Fund, Food Service Fund and Student Activities Fund

A motion was made by Morse, seconded by Backus, to adopt the proposed 2023-24 budget resolution for general fund, community schools fund, food service fund and student activities fund. Motion carried unanimously.

# X. Information & Proposals

A. Child Care Program Discussion

Superintendent Plackemeier shared the following options that have come up in childcare discussions:

- Free tuition for childcare employees Tuition would be free for the first child in the family, and they would receive a 50% discount for any additional children attending childcare at the same time. The employee would have to complete the probationary period (60 days) before they would be eligible for the free tuition option.
- Priority guidelines:
  - o The current guidelines give priority to:
    - 1. Employees of the childcare program
    - 2. HSPS employees
    - 3. Siblings of students in childcare or students in preschool
  - o In-district preference People who live in or work in the boundaries of the school district would receive priority.
  - The waiting list would be used for any open slots after the priority guidelines are applied.
- Registration fee \$25
- Re-visit the fee structure for the 2024-2025 school year depending on grant funding.
- Current rooms and staffing ratios:
  - o Infant/toddler (birth to 30 months): 1 to 4 ratio
  - o Preschool age (30 months to three years): 1 to 8 ratio
  - o 3- to 4-year-olds: 1 to 10 ratio
  - o 4-year-old to school age: 1 to 12 ratio
  - o School age: 1 to 18 ratio
- Potential staff raises Look at 3% to match the rest of the teaching staff in the district

• Tri-Share – Childcare is exploring the option to join Tri-Share as a benefit to their employees. The employer pays one-third, employee pays one-third, and government pays the other one-third. More details on the program can be found at <a href="Michigan Tri-Share Link">Michigan Tri-Share Link</a>. HSPS would need to be a participating employer to offer the benefit to the remainder of the district staff.
